

Terms and Conditions for #MagicalMangrovesCompetition

d. Age Categories: Age 8-10, Age 11-13, Age 14-16.

4. Steps for participation in the Competition:

a. The Participants will have to download the stencil from G&B Mangroves website - www.mangroves.godrej.com for their respective age group.

b. Participants have to mention their name, age, contact details (mobile number & e-mail id) while sending their entry.

c. **The stencils needs to be hand painted and scanned jpg/png copy to be submitted by email to hvk@godrej.com**

d. A brief description (not more 200 words) should be submitted on 'Why Mangroves matter' along with the stencil/painting entry.

e. The Participants will have to adhere to all the Competition requirements for participation.

8. The winners will be chosen at the sole discretion of the judges from G&B and WWF India and the decision shall be final and binding on all Participants and no correspondence will be entered into with the Participants towards any discrepancies raised by the Participants.

9. Winner will be contacted by G&B or WWF India representative via email/social media. Winner needs to share their required details within 72 hours of the name being announced. In case the winner fails to submit his/her required contact details within 72 hours, the gratification for the same will be forfeited.

10. By participating in this Competition, the Participants have agreed and have consented to put up their mention on Social Media platforms of G&B and WWF India. G&B, WWF India will not be responsible or liable for any comments/remarks put on the site/posts/pages by the public.
